

Basic Support Program (BSP): SCSF Home Club Members

May, 2019

This Basic Support Program (BSP) available to all SCSF Home Club members updates our previous 'Competitors' Support Policy' previously adopted by the SCSF Board. This Basic Support Program will be published for all SCSF members to view. This BSP covers the following categories:

- I. Well-Balanced Program (Standard Track), Singles, Dance, and Pair Competitors
- II. Adult Competitors
- III. Tremors Synchro Skating Teams
- IV. San Francisco Ice Theatre (SFIT) Teams
- V. National Solo Dance (NSD) Competitors
- VI. National Showcase Competitors
- VII. Officials Training – Continuing Education
- VIII. Additional Expenses

- I. Well-Balanced (Standard Track), Singles, Dance and Pair Competitions

Entry fee for qualifying events (Juvenile, Intermediate, Novice, Junior, and Senior) paid from the Operating Fund after competitor has skated for Regional, Sectional, and Adult National competitions.

A travel stipend will be paid from the Operating Fund for skaters advancing /initially competing in Sectional Competitions and for those advancing to National Competitions after the skater has competed.

Medal awards for Gold, Silver, Bronze, and Pewter will be awarded at the conclusion of the current fiscal year competition season. These will be funded from the Hickox Memorial Account.

For each fiscal year competition season, there will be a maximum dollar amount set by the Board for each competitor.

A Club membership will be awarded for a US Championship.

A bonus may be awarded to skaters who medal in International competitions.

II. Adults

All Adult skaters who enter the USFS Adult Sectional and/or Adult US Championships will receive a complementary SCSF Adult Skating Team warm-up jacket.

Adults entering US Championships will receive a travel stipend after they have completed.

Adults who receive medals in Championship events will receive a medal award for Gold, Silver, Bronze, or Pewter placements at the conclusion of the current fiscal year competition season. These will be funded from the Hickox Memorial Account.

For each fiscal year competition season, there will be a maximum dollar amount set by the Board for each competitor.

A Club membership will be awarded for a US Championship Adult Qualifying Event.

III. Tremors

Entry fee paid based on a % of SCSF Home Club members on teams competing in qualifying Sectional and National event categories.

Official practice ice for each team entering qualifying event categories paid based on % of SCSF Home Club members on the respective team.

Awards will be given for Gold, Silver, Bronze, or Pewter placements at the conclusion of the current fiscal year competition season. These will be funded from the Hickox Memorial Account.

For each fiscal year competition season, there will be a maximum dollar amount set by the Board for each team.

IV. San Francisco Ice Theatre Teams

Entry fee for Nationals and Nations Cup paid for each team based on the % of SCSF Home Club members on each team.

Official practice ice for Nationals and Nations Cup paid based on % of SCSF Home Club members on each team.

Awards will be given for Gold, Silver, Bronze, or Pewter placements at the conclusion of the current fiscal year competition season. These will be funded from the Hickox Memorial Account.

For each fiscal year competition season, there will be a maximum dollar amount set by the Board for each team.

V. National Solo Dance

Entry fee paid for competitors who qualify for National Solo Dance after they have competed.

A travel stipend will be provided depending on the location of the event.

Awards will be given for Gold, Silver, Bronze, or Pewter placements at the conclusion of the current fiscal year competition season. These will be funded from the Hickox Memorial Account (refer to Final Policy and Awards per FC Meeting 10-15-18).

For each fiscal year competition season, there will be a maximum dollar amount set by the Board for each competitor.

A Club membership will be awarded for US Championship qualification.

VI. National Showcase

Entry fee paid for competitors who qualify for National Showcase after they have competed.

A travel stipend will be provided depending on the location of the event.

Awards will be given for Gold, Silver, Bronze, or Pewter placements at the conclusion of the current fiscal year competition season. These will be funded from the Hickox Memorial Account.

For each fiscal year competition season, there will be a maximum dollar amount set by the Board for each competitor.

VII. Officials Training

Registration fee and/or travel stipend will be paid for officials, trial judges, for certified training to advance or maintain their appointments.

VIII. Additional Financial Assistance

Additional financial assistance may be requested for individuals and teams on a confidential basis based on expenses eligible for reimbursement under IRS non-profit guidelines. Please refer to Financial Assistance Program: Grant Application.
